No flight at this time. **PTB** – Biofix 4/1, 704DD. **CRS** – Biofix 3/24, 628DD. 2nd flight is 2 weeks behind historical timing. **SJS** – Biofix 3/18, 790DD. **OLR** – Biofix 3/14, 1006DD. Second flight expected soon. **NOW** – Biofix 4/28, 330DD.

Tulare County (NE Kingsburg area except where noted): **CM** (Visalia walnuts) – Biofix 4/12, 637DD. **CM** – Kingsburg Biofix 4/12, 621DD. **OFM** – No clear start for F1 flight. Tentative biofix 4/30, 103DD. **PTB** – Biofix 4/16, 597DD **CRS** (Visalia/Exeter) – Biofix 3/30, 545DD.
