Kern County (Delano/McFarland): **CM** – F3 (fourth flight) Biofix 8/24, 154DD. **OFM** – F4 (fifth flight) Biofix 8/13, 598DD. **PTB** – F3 Biofix 8/13, 500DD. **CRS** – F2 Biofix 7/21, 1184DD. 4th flight activity is starting now. **SJS** – F3 Biofix 8/17, 354DD. **OLR** – F3 Biofix 8/13, 527DD. **NOW** – Biofix 8/11, 512D.

Tulare County (NE Kingsburg area): **CM** (Tulare walnuts) – F3 Biofix 8/24, 181DD. Flight was to start 8/24 but is still to be determined. **CM** (Kingsburg plums) – F2 Biofix 7/28, no DD update. **OFM** – F4 Biofix 8/3, no DD update. **PTB** – F2 Biofix 7/25, no DD update. **CRS** – F2 Biofix 7/30, 862DD.
