Generations overlapping now. **NOW** – F2 Biofix 8/8, 131DD. Non Paniel harvest in progress. Many orchards shaken.

Tulare County (NE Kingsburg area): **CM** (Tulare walnuts) – F3 Biofix 8/14, 14DD. **CM** (Kingsburg stone fruit) – F2 Biofix 7/14, 870DD. **OFM** – F4 Biofix 8/7, 213DD. **PTB** – F2 Biofix 7/11, 955DD. **SJS** – F2 Biofix 7/15, 828DD. **CRS** – F2 Biofix 7/14, 802DD. The very important 4th flight should begin about August 26. Traps should be in place at that time.
