**Kern County** (Delano/McFarland): **CM** – F2 Biofix 7/7, 1127DD. 4th flight near. **OFM** – F4 Biofix 8/1, 399DD. **PTB** – F3 Biofix 8/2, 224DD. **SJS** – F3 Biofix 8/5, 221DD. **CRS** – F2 Biofix 7/8, 1100DD. Key 4<sup>th</sup> flight should start soon. **NOW** – F3 Biofix 7/28 (egg trap), 445DD. Non-Pareil harvest nearly over.

**Tulare County** (NE Kingsburg area): **CM** – (Tulare walnuts) F3 Biofix 8/8, 162DD. Next flight should have started 8/8. Still to be confirmed. **CM** - (Kingsburg plums) F3 Biofix 7/26, 530DD. **OFM** – F4 Biofix 8/8, 179DD. **PTB** – F3 Biofix 7/20, 703DD. **CRS** – F2 Biofix 7/15, 835DD. Next flight scheduled to start 8/24. Fourth flight traps should be out by then.

**Madera County:** **CM** – F2 Biofix 7/24, 550DD. **OFM** – F3 Biofix 7/22, 710DD. **PTB** – F2 Biofix 7/19, 675DD. **CRS** – Biofix 3/13, 2575DD. **OLR** – F2 Biofix 7/17, 755DD. **NOW** – Eggs present. Steady moth catch in unsprayed areas. 2475DD since Jan. 1.

**Merced County** (Ballico & Winton areas): **CM** – F2 Biofix 8/3, 235DD. **OFM** – F4 Biofix predicted to begin 8/13. **PTB** – F2 Biofix 7/16, 722DD.

**Sacramento County** (Delta area): **CM** – F2 Biofix 7/20, 554DD. **OFM** – F3 Biofix 7/26, 536DD.

**Yuba County** (Marysville): **CM** – F2 Biofix 7/9, 895DD. **OFM** – F3 Biofix 7/17, 726DD.
